1. I understand this is a team competition and there are activities prior to the competition where mandatory attendance is required – Candidates camp at FTF in Gilroy and Young Rider Camp at Twin Rivers.
2. I agree to compete at one of the three mandatory outings this Spring, although all are encouraged – Galway Downs(April), Twin Rivers(April), Woodside(May).

3. I agree to work with the Young Rider coach on two separate occasions before NAJYRC, either at a horse show or at another discussed location at the instructor's normal rate to better get to know said instructor thus making the team's chances to compete at NAJYRC better.
4. I understand that to be a part of a team, I have to cooperate and work with the other team members, coach, vet, grooms, and chef. I understand that my personal coach is allowed to attend the competition but will not be allowed in the barns and has to communicate with the team coach concerning the schedule; the team agenda comes first.
5. I agree to follow sign the code of conduct and waiver of liability, and abide by them.
6. I understand that the groom selection process is its own entity and I may be able to suggest a groom but he or she may not be selected to go. The riders whose horses get hurt have first right of refusal to go as a groom.
7. I agree to participate fully in all fundraisers, try to raise as much money as possible for the team to offset expenses. I understand I have to sell at least 40 raffle tickets by the drawing in April, as well as complete 12 volunteer hours by camp (the sale of 40 tickets will equal 4 volunteer hours.)
8. I understand that the equipment given to me to use at NAJYRC is owned by the program and must be returned in the way it was received. Thus I agree to give a credit card number to check said equipment out and if the equipment is lost or damaged, the card will be charged.
